Pursuant to the Schulunterrichtsgesetz (school education act), participants are insured against accidents but not illness. Supplementary insurance is therefore recommended. A helmet is mandatory!

EQUIPMENT LIST

1 pair of Alpine skis (preferably freeride skis) and ski poles (large basket)
1 pair of touring skis with touring binding. Snow brakes are compulsory!
Ski boots for the slopes and potentially also touring ski boots (both adapted to the respective ski bindings)
Climbing skins for touring skis (check adhesion)
Ski backpack (with ski attachment option)
ABS avalanche backpack, if available
Compass (liquid damped, transparent bottom, visor mirror)
Avalanche transceiver, 3-antenna device
First-aid equipment (ski instructor first-aid equipment)
Bivouac bag
Avalanche shovel (metal or aluminium, medium to large shovel blade with long shovel handle, extendable)
Snow thermometer
Folding rule
Snow study kit
Backpack probe (no screw probes, minimum length 240 cm)
Sketchbook (A4 format) for profiling, pencil, ruler, coloured pencils
Altimeter
Sunglasses, goggles
Wax and repair kit (tape), Leatherman tool
2 (5-6 mm) nylon cords.* Length: each 5 m long
Coordinate scale for map reading
Snow saw (rip saw- or tree saw) with 30-40 cm cutting length/
'Alpenverein' (Alpine association) map of the Lechtal Alps, Arlberg area, No. 3/2, 1:25.000 ski routes (was distributed in Hintermoos!)

Apparel:

Ski clothing, wool mittens and gloves, sweat suit, indoor slippers, bad weather clothing (waterproof outer clothing), ...
